- 1. Call to order and seating of Chairman Pro-Tem** Chapter 2, Section 9-1 of the Town of Southbridge Home Rule Charter provides for the senior in point of service to serve as Chairman Pro-tem of the Council’s organizational meeting. Town Manager Clark declared Laurent McDonald, Chairman Pro-tem for this Southbridge’s 36<sup>th</sup> Town Council Re-Organizational Meeting.
- 2. Pledge of Allegiance** Councilor McDonald led the council in the Pledge of Allegiance
- 3. Swearing-in of Councilors Elect** – Town Clerk Madaline I. Daoust called Denise Clemence, David Livengood and Laurent McDonald to the table to be sworn in to Council for a term until 2012.

- 7. Election of Vice-Chairman** Councilor Logan nominated. Councilor Vecchia and Councilor nominated Councilor Livengood. A motion was made by Councilor Logan and seconded by Councilor Vandal to vote for either nominee. **VOTE BY ROLL CALL. CLEMENCE-LIVENGOOD, LAZO-VECCHIA, LIVENGOOD-LIVENGOOD, LOGAN-VECCHIA, MCDONALD-VECCHIA, NIKOLLA-LIVENGOOD, REGIS-LIVENGOOD, VANDAL-VECCHIA. VECCHIA-VECCHIA. VECCHIA 5 to LIVENGOOD 4. VECCHIA appointed to Vice-Chairman.**
