1. **Call to order and seating of Chairman Pro-Tem-** Chapter 2, Section 9-1 of the Town of Southbridge Home Rule Charter provides for the senior in point of service to serve at Chairman Pro-tem of the Council's organizational meeting. Town Manager Clark declared Conrad Vandal, Chairman Pro-tem for this Southbridge's 38th Town Council Re-Organizational Meeting.
2. **Pledge of Allegiance-** Councilor Vandal led the Council in the Pledge of Allegiance.
3. **Swearing-in of Councilors Elect** – Town Clerk Madaline I. Daoust called David Langevin, Darlene Marcucci and Cathie Nikolla to the table to be sworn in to Council for a term until 2014.

6. **Election of Permanent Chairman-** Councilor Langevin nominated Councilor Nikolla. A motion was made by Councilor Langevin to elect Councilor Nikolla seconded by Councilor Regis. **VOTE BY ROLL CALL. Those in favor: LANGEVIN, LIVENGOOD, MARCUCCI, NIKOLLA, REGIS, SPINELLI and CLEMENCE. Those opposed: VANDAL. Present: MCDONALD. MOTION PASSES.**
7. **Election of Vice-Chairman-** Councilor Regis nominated Councilor Clemence. A motion was made by Councilor Regis to elect Councilor Clemence seconded by Councilor Langevin. **VOTE BY ROLL CALL. Those in favor: LIVENGOOD, MARCUCCI, NIKOLLA, REGIS, SPINELLI, CLEMENCE and LANGEVIN. Those opposed: VANDAL. Present: MCDONALD. MOTION PASSES.**
8. **Adoption of permanent seating arrangement (The newly elected Chairman will direct this procedure)** - Madaline Daoust facilitated seating arrangements with assistance by New Chairwoman Nikolla. Seating is as follows:
